

# HIGH RISK FOR FRAUD, WASTE, AND ABUSE

Created by federal mandate, non-emergency medical transportation (NEMT) is a Medicaid benefit designed to help ensure beneficiary access to medically necessary services [P.L. 116-260]. Though the scope varies by state, NEMT generally covers a range of transportation to and from medical appointments for Medicaid beneficiaries with no other means of accessing services to which they are entitled.


States have discretion over the systems of delivery for their NEMT programs, which commonly include fee-forservice, managed care plans, third-party broker. States must implement effective oversight of the NEMT program to ensure proper rendering, documenting, and billing of services in compliance with federal and state regulations.

Studies by the Health and Human Services Office of the Inspector General have found inadequate oversight and improper payments for trips that did not meet federal and state requirements. For those reasons, federal oversight authorities have identified the NEMT program as high risk for fraud, waste, and abuse.
